Minutes of Meeting on November 3, 2022

At 6:34 p.m. on Thursday, November 3, 2022, a meeting of the Finance and Audit Committee was held at Fairfax Water with the following in attendance:

Upon separate motions duly made, seconded, and unanimously carried, unless otherwise noted, the following actions were taken:

Adoption of Minutes

The Committee approved the minutes of October 20, 2022.

Trust Engineer Inspection

Mr. Cronin from Greeley and Hansen provided an overview of the Trust Engineer inspection of the Fairfax Water facilities on Wednesday, November 2, 2022, and Thursday, November 3, 2022. Mr. Cronin concluded that the facilities are in good condition and being well maintained, with a good plan for future needs.

Mr. Cronin also reviewed the Fairfax Water Advertised Annual 2023 Budget document and found the budget reasonable and adequate to maintain the water system, to meet debt requirements, and to continue funding the Capital Improvement Program (CIP).

Presentation of Preliminary 2023 Annual Budget

Ms. Oates gave a presentation on the Preliminary 2023 Annual Budget including an update on 2022 projections. Revenues in 2022 are expected to be approximately \$3.6 million below budget. Most of the decrease is attributable to wholesale water revenues driven by a delay in billing for the Occoquan Tunnel project. Water sales volume in 2022 is estimated to be 674 million gallons less than 2021, a 1.2% decrease.

Budgeted revenues in 2023 of \$228.4 million are \$24 million (11.7%) higher than the 2022 current estimate.

Budgeted expenses in 2023 of \$116.4 million are \$13.3 million (12.9%) higher than the 2022 current estimate and \$9.8 million (9.1%) higher than the 2022 Annual Budget.
