In addition, you agree to defend, indemnify and hold Fairfax Water and its agents, employees, officers and directors, harmless from and against all claims, demands, obligations, losses, fines, penalties, liabilities, damages (including consequential damages), costs, expenses, and suits, including, without limitation, reasonable attorneys' fees and costs of defense, imposed upon, incurred by or asserted against Fairfax Water as a result of your construction of improvements in accordance with this license.
