1)	Is there a physical address location for the drop of the cold patch?	<p><i>The possible delivery locations are as follows:</i></p> <p><i>Newington Maintenance Facility</i> <i>8001 Cinder Bed Road</i> <i>Lorton, Virginia 22079</i></p> <p><i>Chantilly Maintenance Facility</i> <i>4400 Henninger Court</i> <i>Chantilly, Virginia 29151</i></p> <p><i>Falls Church Maintenance Facility</i> <i>217 Gordon Road</i> <i>Falls Church, Virginia 22046</i></p>
2)	Would Fairfax Water be open to accepting Water Activated cold patch to be an approved equal on this bid?	<p><i>We have used this product in the past for small areas needing a patch. However, it is not appropriate replacement for cold mix asphalt. So no, it would not be considered an approved equal.</i></p>
3)	I noticed in section 2 item 7. FW will order a minimum of 10 tons for each pick up or delivery. Any exception to require a larger amount shall deem your bid as non-responsive.	<p><i>Each delivery location has limited to space to store material and can receive between 30 to 50 tons depending on location. However, there may be time when less than the maximum that can be received will be ordered to ensure the location has</i></p>

<p>We deliver full loads 23 to 25/ton to utilize full capacity of the truck I assume that full loads will not be a problem when you are estimating 1300/ton of material.</p>	<p><i>sufficient amount of cold mix. At no time will the minimum amount ordered be less than 10 tons.</i></p>
