

CONTRACT AMENDMENT #1

Annual Economic Price Adjustment


The Contractor may submit a request for contract price increases once annually for each renewal year. Economic increases shall be limited to the increase specified in the Bureau of Labor Statistics PPI series *PCU3329193329194 Metal fittings, flanges and unions for piping systems*, not seasonally adjusted, for the 12-month period ending 90 days prior to the end of the then current contract year. Requests for contract price increases must be submitted at least 30 days prior to the end of the contract year.

In all other respects not specifically mentioned or altered by Amendment, the original Contract shall remain in full force and effect.
